in consideration of the sum of Five Hundred Dollars lawful money
of the United States of America to them in hand paid by the said party of the
second part at or before the making and delivery of these presents the
receipt whereof is hereby acknowledged have remised released and
quit claimed and by these presents do remise release and quit claim
unto the said party of the second part and to his heirs and assigns forever
all of that certain lot or parcel of land situated in the town of Shasta
County of Shasta & State of California & described as follows, beginning
at the south west corner of lot owned by J. N. Priel and occupied
by the Shasta Steam Mills on the East side of High Street running
from thence in an easterly direction on the south line of said Steam
Mills lot through Main Street to the south west corner of said
Priel's lot, from thence along said Main Street in a southerly
direction to a point where main and High Streets connect from thence
on a line of High Street to the place of beginning

Together with all and singular the tenements, hereditaments & appurtenances
thereto belonging, or in any wise appertaining, and the reversion
and reversions, remainders and remainders unto issues and
profits thereof, And also all the estate right title interest property
possession claim and demand whatsoever, as well in law as in equity
of the said party of the first of, in or to the above described premises
and every part and parcel thereof with the appurtenances,

To Have and To Hold all and singular the above mentioned and
described premises together with the appurtenances unto the said
party of the second part his heirs and assigns forever.
